Elementary (Grades K - 4): 100% online instruction for all students.

Middle School (Grades 5 - 8): 100% online instruction for all students.

High School (Grades 9 - 12): 100% online instruction for all students.

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

In-person instruction for some special education programs paused on November 12th.
