Committee Facilitator Catherine Ash presented information from the Leadership Council regarding additional recommendations for facility upgrades in the areas of athletics, physical education, fine arts, transportation, safety, security and miscellaneous. These items were identified in the Kingscott Facility Assessment and/or the original Facility/Site Committee report.

Additional Facility Recommendations

Level one recommendations include upgrading the fire alarm systems; tennis court maintenance; lighting upgrades, renovation of restroom facilities; addressing parking and traffic flow; auditorium curtains and flooring; and removing underground fuel tanks. Additional considerations for fine arts and athletics were described.

Members inquired about the following: the additional fine arts room; decreasing the non-transportation area to help alleviate the traffic and parking issues; and high school pool specifications.
