Okemos High School Principal Christine Sermak and teacher Trisha Funk presented an update on the high school's no homework during break philosophy and communication plan for the upcoming winter break.

Presentation: No Homework Policy

Assistant Superintendent Stacy Bailey provided an overview of the English Language Learner programming. ELL teachers Torey Alchin, Michelle Arndt, Julie LeGoulven and Melissa Sainz discussed the goals for the ELL program and introduced who English Learner students are. They also described our EL population, trends, and explained the multiple supports available in the district. Support is provided in a variety of ways including: instructional support; accommodations; push-in and differentiation; behavior support; cultural competency; screenings and assessments, continuous monitoring; and administrative tasks.
