Call To Order

24 Years of Service

Ingham ISD Superintendent Jason Mellema presented information regarding an upcoming March 10th election with a Headlee Restoration for Special Education on the ballot. Mr. Mellema explained the Headlee amendment that has led to the erosion of a 4.75 mills levy down to the current 4.5. The restoration would generate \$2.3 million annually for 20 years in support of special education students in the Ingham ISD service area. For the average taxpayer, the cost would be \$1.27 per month. This is not an additional millage, rather it restores what was approved by taxpayers in 1998.

IISD Headlee Restoration Election

Members inquired about special education enrollment; equity and how districts are prioritized; what is needed for the vote to pass; and the special education funding committee. Additional information can be found on the OPS website homepage.

Construction Manager Rob Crowe from The Christman Company presented information regarding the bid process, administration's recommendation, timelines and next steps as they pertain to the installation of 3M window film. The board will take action on this project at their February 10th meeting.

Bond Project: 3M Window Film

Members inquired about the lifespan of the film, instruction interruptions, clarity, and if the new classrooms at Bennett Woods will be included in the project.

Construction Manager Rob Crowe and Operations Director Steve Lathrop presented information regarding LED lighting, electrical, air conditioning and bathroom upgrades, the bid process, timelines and next steps as they pertain to this project. Mr. Lathrop explained that the project will occur over the course of two summers, as well as the use of the building and site sinking fund to supplement the cost. Rebates from Consumers will significantly subsidize the cost of the LED lighting. The board will act on these projects at a future meeting.

Bond Projects: LED Lighting, Air Conditioning & Bathrooms

Operations Director Steve Lathrop provided information regarding a Building and Site Sinking Fund project for roofing at Chippewa Middle School and a Capital Outlay fund project to upgrade and replace the radio communication system across the district. He also described safety and security features of the radio system, installation and programming.

Building & Site Sinking Fund Projects Superintendent Hood reported on the following: enrollment update with a projected increase of 82 students; draft superintendent goals; health data apps utilized in physical education classes; CMS Parent Group meeting including a presentation regarding tweens and teens on February 13th; school board appreciation month; and OHS Student Council's soles for souls shoe drive.
