The Regular meeting of the Okemos Board of Education was called to order by President

Vincent Lyon-Callo arrived at 7:06 p.m.

Sex Ed Supervisor Nicole McGuire presented the recommendations from the district's Parent Council for four appointments to the district's Personal Health and Sexuality Education Advisory (PHASE) Board as follows: one clergy, Rev. Neal Anderson; one healthcare professional, Martha Nokken; and two community members at large, Stephanie Nawyn and Sabrina Avripas. The board will take action on these recommendations at the November 8th board meeting.

PHASE Board Members

Assistant Superintendent Stacy Bailey provided information regarding the M-Step, PSAT and SAT assessments taken by some students during the 2020-2021 school year. Mrs. Bailey reminded the board that these test were optional during the 20-21 school year. Okemos had the largest number of students in the county to take the assessments. Okemos students outperformed the State average in every subject. Limitations regarding the data were reviewed. Benchmark assessment data as well as social-emotional screener data will be shared at the next meeting.

Assessment Data

Members inquired about the following: data from the 19-20 school year to compare; percentage of students who tested and how it correlates with remote vs. in-person percentages; longer term trend data; how the district is addressing gaps; and changes to curriculum as a response.

Assistant Superintendent Stephen Keskes presented information regarding alternate pathways to teacher certification and the district's approach to the new legislation. OPS best practices in hiring were outlined, and the different types of certification available were described. To help manage the teacher shortage, the State is now offering an Interim Teaching Certificate. Mr. Keskes explained the requirements for the new certificate, as well as the OPS approach for supporting these teachers. A collaborative agreement with Okemos Education Association has been drafted.

Alternative Certification

Members discussed the following: exclusionary language in the collaborative agreement; why the need to differentiate between teachers with interim certificates and those with provisional or professional certificates; impact on staffing and diversifying teaching staff; and preference versus policy.

Kayla Byrd-Daniels addressed the board regarding behavioral interventions.

Superintendent Hood reported on the following: additional crossing guard; adjustment to approaching elementary volunteers; parent-teacher conferences; Covid equalization payments; enrollment update; substitute teachers; potential 2022 bond and communication
