**OEF** Update

Director of Finance Elizabeth Lentz and Mr. Steve Piesko, CPA and principal from Maner Costerisan P.C. presented the 2021-2022 draft audit report of the district. Mr. Piesko commended the district's financial management, as well as recognized the lower than state average variance of the projected 2021-2022 budget and the actual budget. Mr. Piesko pointed out several areas of note including debt funds that have been paid off; compliance audit of the food service budget and spend down plans; fund balance; and GASB's regarding leases and online curriculum subscriptions.

2021-2022 Audit Report

Assistant Superintendent Bailey provided an update regarding the learning opportunities utilized during summer of 2022. Programs offered were elementary literacy, virtual tutoring, credit recovery, special education programs, ELL and Kids Read Now. She also described the number of students served, types of programs offered, funding sources, eligibility requirements, growth outcomes, and data points to assess the success of the program.
